2. Public Comments on Agenda Items: None.

  - Discussed the status of purchasing Profit Island.
  - Updated the Board on the status of expropriating the Irene Road entrance.
6. Report by ARBC Legal Counsel
  - Further discussed the status of purchasing Profit Island as mitigation property.
  - In regard to utility relocations, a legal process of Rules and Regulations need to be adopted.
  - Sent soil study to EBR City Parish because they are interested in purchasing the stockpiled dirt on a long term basis.
  - Did not enter into Executive Session
7. Old Business: Irene Road Expropriation: The Board unanimously approved a motion by Rouchon second by Hoover to authorize and additional payment of \$16,000 as an administrative settlement for Tract 100E. Further, agreement to relocate the access road along the owners property line at the sole cost of the property owners, if ordered by the court.

  - a. The Board unanimously approved a motion by Thibeau second by Hoover to add "Consideration of ARBC generating an Amite River Weir Letter to Ponchartrain Levee District."
  - b. The Board unanimously approved a motion by Babin second by Rouchon to write a letter to PLD requesting assistance with the Amite River Weir study.
  - c. It was agreed upon to schedule the next regular ARBC meeting on February 24, 2015 due to Mardi Gras.
